

**Lincoln Christian University
Seminary – Counseling Faculty Position**

Lincoln Christian University invites applications for a full-time faculty member in the area of Counseling for their CACREP-accredited master's program, effective June 1, 2020. Primary teaching responsibilities will be in LCU's embedded Seminary.

Qualifications: Have an earned Doctorate in Counselor Education and Supervision, preferably from a CACREP accredited program or have related doctoral degrees and have been employed as full-time faculty member in a counselor education program for a minimum of one full academic year before July 1, 2013. Membership in a professional counseling organization (ACA and/or its divisions) and appropriate certification and/or licensure for practice required. Significant experience in both teaching and counseling preferred. Evidence of scholarly and professional engagement or contribution desired. Volunteer/professional church ministry or pastor care experience highly valued.

Responsibilities for the position include teaching graduate-level coursework, group and individual student supervision, and some clinical oversight and counseling within the LCU Counseling and Consultation Center.

Applicants should possess a passion for teaching, a spirit of collegiality, and an ability to draw prospective students and support recruitment efforts. Applicants should support the University's mission, core values, basic beliefs, philosophy of education (documents available at www.LincolnChristian.edu). Given the nature of this position, preferential consideration will be given to active members of independent Christian Churches or Churches of Christ, as these represent the University's primary religious constituency.
